CONVENTION SUB-COMMITTEES

SUB-COMMITTEE ADMINISTRATIVE GUIDELINES

1. Submission of Correspondence

All official submissions, including budgets, reports, requests, and memoranda, shall be formally addressed to the Secretary of the National Convention Central Coordination Committee through the National Convention Central Committee Secretariat.

2. Channel of Communication

All communications from Sub-Committees to the National Convention Central Committee must be routed through the Secretariat. Direct correspondence to the Chairman, Secretary or other principal officers without Secretariat processing is discouraged.

3. Management of Digital Platforms

The National Convention Central Committee Secretariat shall be solely responsible for the creation, administration, and management of all official WhatsApp groups, digital platforms, and communication accounts related to the National Convention Central Committee.

4. Authorization of Digital Communication

No Sub-Committee shall independently operate an official WhatsApp group, email channel, or digital communication platform in the name of the National Convention Central Committee without prior approval from the Secretariat.

5. Budget Coordination

All Sub-Committee budgets must be submitted through the Secretariat for review, harmonization, and presentation to the leadership of the Convention Committee.

6. Documentation and Record Keeping

The Secretariat shall maintain official records of all submissions, approvals, minutes of meetings, and communications relating to the activities of the National Convention Central Committee and its Sub-Committees.

7. Meeting Coordination

Sub-Committee meetings may be convened by the Chairman or Secretary of the National Convention Central Coordination Committee at any time.

8. Official Announcements

Only information cleared by the Secretariat shall be regarded as official communication of the National Convention Central Coordination Committee.

9. Reporting Structure

Each Sub-Committee shall provide periodic progress reports to the Secretariat for onward transmission to the leadership of the National Convention Central Committee.

10. Protocol and Compliance

All Sub-Committees shall operate in line with the directives of the National Convention Central Committee and the Constitution of the All Progressives Congress.

11. Coordination Among Sub-Committees

Where collaboration between Sub-Committees is required, such coordination shall be facilitated through the Secretariat to ensure proper alignment of activities.

12. Amendment of Guidelines

These guidelines may be reviewed or amended by the National Convention Central Committee leadership as necessary to ensure effective coordination of the Convention process.
